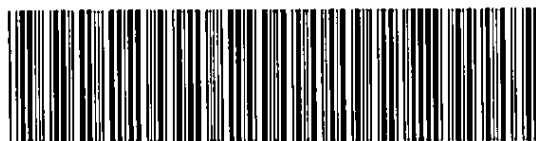

- (e) Description of the relief requested and, if such relief is monetary, then the amount of the relief requested.


