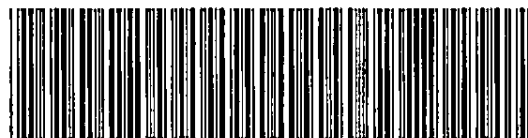

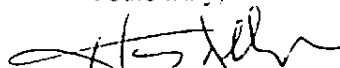

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida for profit corporation adopts the following Amendments to its Articles of Incorporation:

ARTICLE III of the Articles of Incorporation and as amended be, and is hereby, deleted in its entirety and replaced with the following:

“ARTICLE III CAPITAL STOCK

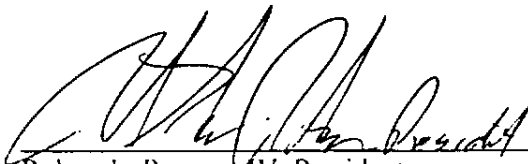
The authorized capital stock which the corporation may issue shall be 200 shares of non-par value common stock, which shall be non-assessable and held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time, determine.”

Section entitled THIRD as set forth in Article or Amendment to Articles of Incorporation of Multisoft Corporation filed January 11, 2011, is hereby deleted in its entirety.
