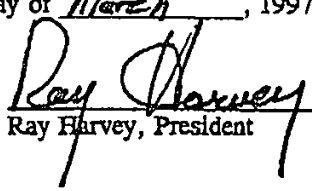
Pursuant to Sections 607.1001, 607.1004, 607.1006, and 607.1009, Florida Business Corporation Act, the following provisions of the Articles of Incorporation of Florida Group of Jacksonville, Inc., a Florida corporation, filed in Tallahassee on January 28, 1993 be and they hereby are amended in the following particulars:

Article 1, Section 1.1 be and it hereby is amended to read as follows:

"The name of this corporation is FGI, Inc. "

The foregoing amendment was adopted by the Stockholders and Directors of the corporation on the 26th day of February, 1997. The only voting group entitled to vote on the adoption of the Amendment consists of the holders of the corporation's common stock. The number of votes cast by such voting group was sufficient for approval by that voting group.

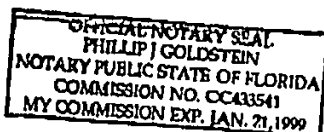
