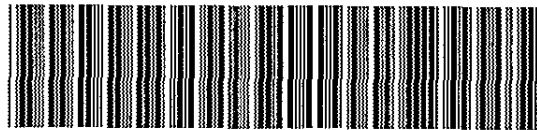

It has come to our attention that when we filed our Articles of Dissolution in June 1999 that they were never correctly filed with your office. We did not know this until January 2003 however because the packet was never returned to our corporate PO Box, and we never received a letter from your office advising us of any problems with the Dissolution filing.

When I called today and spoke with the Amendment section, I was told that it might have to do with the fact that we failed to include a check for the Dissolution filing back then. 
