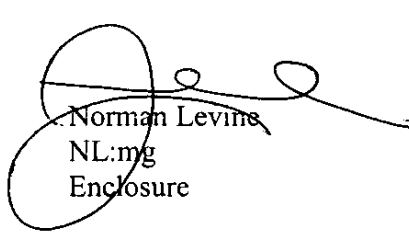
We are the accountants for the above referenced taxpayer and your Notice of Intent to Dissolve was turned over to our office for a response.
