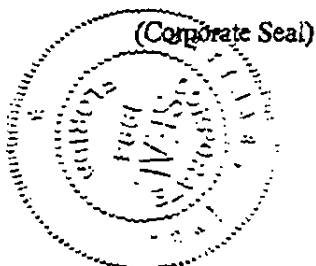
1. The name of the Corporation is: BETTMAR, INC.
