Pursuant to the provisions of Section 607.1006, Florida Statutes, NOBLETT & ASSOCIATES, INC., a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** Article III of the Corporation's Articles of Incorporation has been amended to read as follows:

**"Article III**

**Capital Stock**

The total number of shares of all classes of capital stock which the Corporation shall have authority to issue is One Thousand (1,000), consisting of Five Hundred (500) shares of Voting Common Stock with a par value of \$.10 per share (the "Voting Common Stock"), and Five Hundred (500) shares of Non-Voting Common Stock with a par value of \$.10 per share (the "Non-Voting Common Stock") (Voting Common Stock and Non-Voting Common Stock being hereinafter referred to collectively as "Common Stock").

The following is a statement of the designations and the powers, privileges and rights, and the qualifications, limitations or restrictions thereof in respect of each class of capital stock of the Corporation.

Except as otherwise provided herein, all of the shares of Voting Common Stock and Non-Voting Common Stock will be identical in all respects and will entitle the holders thereof to the same rights and privileges.
