RE: Corporation Reinstatement


Dear Financial Agent:

Pursuant to receipt of your request for reinstatement of my corporation "Lone Palm Trading Company", I have enclosed a check for \$450 for each of the prior years 2000 and 2001 along with payment for 2002 and the reinstatement form. I understand that my corporation was placed inactive upon non-receipt of the 2000 payment. This was due to the fact that my accounting firm moved and the 2000 report was not forwarded to their new address.
