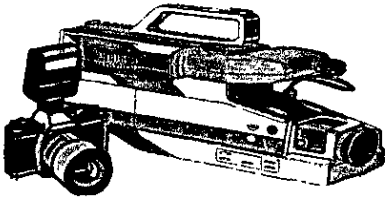


At this time we are requesting a correction of information to show the mailing and business address to be one in the same as follows:
