Enclosed please find the 2001 Uniform Business Report for Dead River Investment Co., Inc. and their check for payment in the amount of \$150.

It is respectfully requested that the \$400 penalty be abated for the following reasonable cause.

The President and Director of the corporation, Mr. C. W. Shepherd III, died on February 14, 2001 from a self-inflicted gunshot wound. A copy of his obituary and newspaper article are attached as evidence. His widow, Mrs. Debra H. Shepherd, Secretary and Director of the corporation, was hospitalized shortly after Mr. Shepherd's death for a period of five weeks and is just now recovering.

My office received yesterday a letter from the Current Registered Agent, Steven J. Richey, (copy attached) informing me that the 2001 Uniform Business Report for the corporation had not been filed and was past due. I immediately contacted Mrs. Shepherd and she responded promptly to my request for her signature on the report and payment of the \$150 fee.

If you should decide to not abate the \$400 penalty please notify the New Registered Agent so that the deadline does not go past September 12, 2001.
