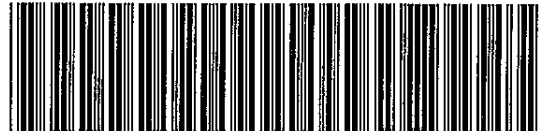

OF
ARTICLES OF INCORPORATION
OF

The undersigned, COMANCO Environmental Corporation (the "Corporation"), a Florida corporation, pursuant to Section 607.1007 of the Florida Business Corporation Act, hereby restates its Articles of Incorporation as follows:

ARTICLE I

Name

The name of the corporation is Comanco Environmental Corporation.

ARTICLE II

Principal Office Street Address and Mailing Address

The street address and mailing address of the Corporation's principal office is 7911 Professional Place, Tampa, Florida 33637.

ARTICLE III

Shares

The corporation shall have authority to issue 100,000 common shares with a par value of \$0.01 per share.

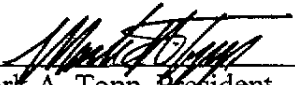
This Certificate accompanies the Restatement of Articles of Incorporation of COMANCO Environmental Corporation (the "Corporation").
