
Dear Madam or Sir:

We are writing on behalf of the above named taxpayer to respectfully request you please waive the penalty assessed for late filing of the 2005 Annual Report/Uniform Business Report. The taxpayer never received the original report. They acknowledge the Report was filed after the original May 1, 2005 due date, but respectfully request you accept the enclosed check for \$150 and abate the \$600 penalty due to non-receipt.

The taxpayer did not receive the original UBR. I know the only provision the Division of Corporations has for waiver of the late fee is due to non-receipt of the original UBR. That is definitely the instance here.
