filing of 1997 (4/11/97).

We had moved from Hollywood to Coral Gables on Giralda Ave and
precisely on April 15 1997 to 126 Miracle Mile, at such time
Mr Pratts who was one of the officers and was acting as
Registered Agent, had to resign due to some serious health
problems and provisionally moved to California to have some
surgery done, before he left he filed a change of address with
the Post office for the Corporation, in Coral Gables, and one
for him personally, from his place in Ft Lauderdale.

The reason he did not file a change of reg rep is because he
