TEWKSBURY, INC. (the "Corporation") and hereby certifies the following:

- 1. The name of the Corporation is "R.L. TEWKSBURY, INC."
- The original Articles of Incorporation of the Corporation were filed with the Florida Department of State on March 2, 1993, under document number P93000015959.

- Article I of the original Articles of Incorporation shall be and hereby is amended by replacing Article I in its entirety to read as follows:
