Please be advised that in 1996 Daystar Development Company ceased to do business as a real estate brokerage previously operating as VR Business Brokerage, formerly located at 5405 W. Cypress St.; Suite 118; Tampa, FL. 33607.

We filed an address change with the postal system and the new address of Daystar Development Company is 702 S. West Shore Blvd.; Tampa, FL. 33609. We filed a Florida Tangible Report and Florida Intangible Tax (\$0 due) Report for 1996. We never received the forms for the Corporate filing and because of this, it was overlooked as being due for 1996.
