This office represents the above referenced corporation and serves as it Registered Agent.

We were surprised to receive from your office a "2nd Notice" of filing the annual report with the State for this corporation. On January 4, 1997, a check (No. 1252) in the amount of \$165.00, together with the report form, was sent to your office in the envelop provided by the State. Upon receipt of the 2nd Notice, bank records were checked and we determined that the above referenced check was not cashed. Further, the envelope has not been returned to their office by the Post Office. We must, therefore, conclude that it was delivered to your post office box by the U.S. Post Office.

I have instructed the company to notify the U.S. Post Office to conduct an investigation into this matter; however, I doubt that it will result in any satisfactory answer as to why the envelope was not delivered. I ask that you conduct a further check of your mail distribution system and check receipt log to determine if it was received.

It appears to be unfair to the company to force them to pay \$550.00 at this time, especially since Florida maintains the highest report fee we have seen in the United States. We certainly appreciate the fact that the fees were lowered last year for timely payment.

We are asking for a waiver of the special assessment fee in this matter based on the circumstances cited above. If acceptable, a duplicate report with the original assessment fee will be forthcoming before September 17, 1997. We, of course, will pay for the stop payment on check number 1252 with the bank.
