Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is MEDICAL RECORDS DISPOSAL, Inc. (hereinafter referred to as the "Corporation").

Article II - Adoption and Text of Amendments

RESOLVED, that Article 1 of the Articles of Incorporation of the Corporation be amended in its entirety to read as follows:


"ARTICLE 1 - Name. The name of this Corporation shall be SECURE WASTE DISPOSAL, INC.
