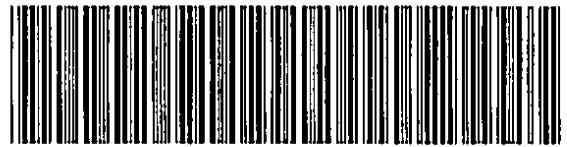

Item 1: The Officers of the Corporation are hereby amended as follows:


Remove	President	Prior E. Powers
