## ARTICLES OF AMENDMENT

1. The following provision of the Articles of Incorporation of HARBOR ORTHODONTICS, INC., a Florida corporation, filed in Tallahassee on March 1, 1993, be and it hereby is amended in the following particulars:

Article I., NAME, be and it hereby is amended to read as follows:

The name of this corporation is MICHAEL S. WOODDELL, P.A.

Article II., NATURE OF BUSINESS, be and it hereby is amended to read as follows:

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of dentistry/orthodontics, and all its fields of specializations, as are engaged in by dentists and orthodontists.
- b.
