

*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**I. ARTICLE I - CORPORATE NAME**

WHEREAS, it is now deemed expedient to change the name and title of the Company, be it

RESOLVED, that the name and title of this Company be changed from BOBBY WILLIAMS ENTERPRISES, INC. to ALW ENTERPRISES, INC., and that the officers of the Company are hereby empowered and directed to file in the office of the DIVISION OF CORPORATIONS, the requisite certificate setting forth the change of name hereby authorized and effected.
