FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION OF FLYNN ENGINEERING SERVICES, P.A. a Florida Corporation

THIS AMENDMENT dated this day of November, 2022, shall constitute the First Amendment to the ARTICLES OF INCORPORATION OF FLYNN ENGINEERING SERVICES, P.A., (a copy of which is attached hereto, incorporated by reference herein, and hereinafter referred to as the "Articles"). The Board of Directors, with the approval of the Shareholder, hereby unanimously agree to amend the Articles, as follows:

FIRST: Articles IV. is deleted in its entirety, and the following is hereby added in its place and stead:

ARTICLE IV

The Corporation is authorized to issue only one class of shares of stock, and such class shall be designated as "Common Stock". The total number of shares of Common Stock which this corporation is authorized to issue is Five Million Five Hundred Two Thousand (5,502,000).

SECOND: The following is hereby added after Articles VIII:

ARTICLE IX

In accordance with Florida Statute § 607.0858, any person made or threatened to be made, a party to any threatened, pending or completed action or proceeding, whether civil, criminal, administrative, or investigative, because such person is or was a Director, Officer, or agent of this Corporation, shall be indemnified by this Corporation, and this Corporation may advance such person's related expenses to the full extent permitted by law. The foregoing right of indemnification or reimbursement shall not be exclusive of other rights to which the person may be entitled.

THIRD: The remaining terms and conditions of the Articles are hereby ratified and confirmed.


