My accountant recommended that I should call Tallahassee to clear this matter.


So I called today and spoke with Michelle. I told her that I didn't know about this form and that this form was due by May 01. I also told her that I never received a form or any notice about the filing requirements.

Michelle told me that I could download the form from the INTERNET and that I should file it immediately. I should enclose a check for \$150 --- and a letter that states that I never received a first notice.

This is what I'm doing now:

- I assure you that I did not receive a notice to file the report or a form in the mail. Otherwise I would have filed the form before May 01.
- I should have known about the filing requirements but I didn't. There are so many things to watch as a Corporation... For that reason I reserved a few weeks ago a place at Sarasota for the Small Business Tax Workshop on June 07 to learn about all the laws and filing requirements. So in the future it will not happen again that I miss a deadline.
- I beg you to waive the late fee.
