ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006, *Florida Statutes*, the undersigned Florida corporation adopts the following amendment to its Articles of Incorporation.

1. The Articles of Incorporation are hereby amended to add the following:


PRE-EMPTIVE RIGHTS

Each shareholder of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the subscription price offered by the corporation, a pro rata portion of any stock of any class that the corporation may issue or sell."

2. The amendment was approved by the board of directors and the shareholders of the corporation by written consent dated as of October 1, 2012. The number of votes cast for the amendment by the shareholders was sufficient for approval.
