ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF DECISION MANAGEMENT INTERNATIONAL, INC.

Decision Management International, Inc. (the "Corporation"), pursuant to the provisions of Fla. Stat. §607.1006, adopts this Articles of Amendment to its Articles of Incorporation effective December 1, 1999:

1. Article III is amended in its entirety to read as follows:

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 1,000,000 shares of common stock having a \$.01 par value per share.
