7. The Corporation has elected to dissolve on the unanimous written consent of its shareholders and directors. A copy of the consent is incorporated and attached as "Exhibit A".

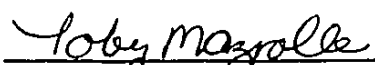

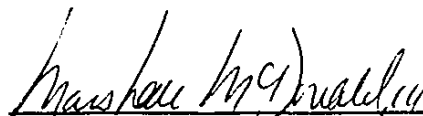

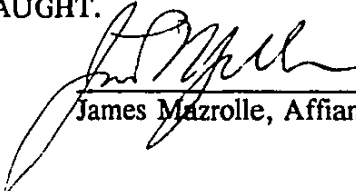
### AFFIDAVIT

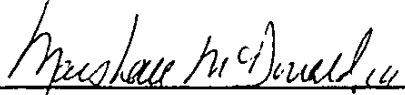
