11. *Chlorophyll a* and *Chlorophyll b* were determined in the whole cells of *Chlorella* and *Scenedesmus* by the method of Lichtenthaler and Whistler (1973). The cell suspension (10 ml) was extracted with 10 ml of 80% methanol. The extract was centrifuged at 1000 g for 5 min. The supernatant was evaporated to dryness under reduced pressure. The residue was dissolved in 1 ml of 80% methanol. The absorbance of the solution was measured at 663 nm and 646 nm. The concentration of *Chlorophyll a* and *Chlorophyll b* was calculated from the absorbance values using the following equations: $Chl\ a\ (mg\ l^{-1}) = 12.7 \times A_{663} - 8.29 \times A_{646}$ and $Chl\ b\ (mg\ l^{-1}) = 22.9 \times A_{663} - 18.44 \times A_{646}$.
