March of 1993, I signed a five year lease at 1179-21 Blanding Blvd. In May of 1996, I received notice from the Postal Department that the address, after being in business for three years, was incorrect at this location. The incorrect address was 1179-21 Blanding Blvd., the correct address now is 1241-21 Blanding Blvd.

With the cooperation of the Postal Department in 1996, we decided the most efficient way to handle this major problem was to have ALL mail forwarded to my office address which is 2869 GATLING BLVD., ORANGE PARK, FL. 32065.


I proceeded to notify all major concerns with the proper change of address form provided by the Postal Department. The State of Florida, and the Federal Department of Taxes, were all notified under both of my corporate numbers, tax #20-00-013427/08, and FEI #59-3182587, of the address change.

Approximately March of 1997, the 1179-21 address became non-existent, as per the Postal Department. All mail sent to this address would be returned to sender.

To receive this notice of Dissolution was a shock to me. This is the only important piece of mail from State, or Federal that the address change did not reach the proper department. All were notified.
