Pursuant to Section 607.1403, *Florida Statutes*, the undersigned Florida corporation (the "*Corporation*") executes these Articles of Dissolution for filing with the Department of State of the State of Florida for the purpose of dissolving the Corporation:

ARTICLE I - Name

The name of the Corporation is Triple C Enterprises, Inc.

ARTICLE II - Date Dissolution Authorized

The dissolution of the Corporation was authorized on December 29, 1998.

ARTICLE III - Approval of Dissolution

Pursuant to and in accordance with Sections 607.0704, 607.0821 and 607.1402, *Florida Statutes*, the shareholders and directors of the Corporation took appropriate corporate action to authorize the dissolution of the Corporation. The dissolution of the Corporation was approved by the written consent, dated and effective December 29, 1998, of the holders of more than a majority of the outstanding common stock of the Corporation (the only voting group entitled to vote on dissolution), and the number of votes cast for dissolution of the Corporation was sufficient for approval.
