RP HEALTH, INC.**


1. The name of the corporation is "RP Health, Inc."

ARTICLE I


The name of the corporation is "Paradigm Mandarin, Inc."

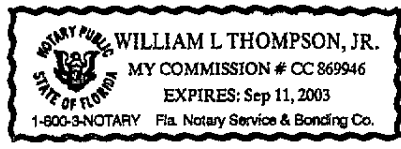



