To Whom It May Concern:

It has come to my attention that our corporation, B & B Telecommunications, Inc. (dba Empire Vending), FIE number 650-429670, was subject to administrative dissolution for not filing the required corporate annual reports since CY 2001. The reason the reports were not filed was because we did not know they were required and never received any notices that they were due. The reason we did not receive the notices was because our business changed its office location and the notices apparently went to the old address and were not forwarded to the new address. Our old address was 10058 Spanish Isle Blvd. Ste. F28, Boca Raton FL. Our business moved its address to 6401 E. Rogers Circle, Boca Raton FL 33433, where we are currently located.

We are now filing to have our corporate status reinstated and, given the inadvertent reason for the administrative dissolution resulting from our change of address, we are respectfully requesting that the prior year's reinstatement fees please be waived. Accordingly, I am including along with this letter a completed reinstatement application along with a check in the amount of \$758.75. Of this amount, \$750.00 represents the "Minimum Amount Due" (Reinstatement Fee; Annual Report Fee; Corporate Supplemental Fee) and \$8.75 represents payment for a "certificate of status".
