

#### AMENDED AND RESTATED ARTICLES OF INCORPORATION OF LAKE SIDE ANIMAL CLINIC INC.

These Amended and Restated Articles of Incorporation of Lake Side Animal Clinic Inc., a Florida corporation (the "Corporation"), dated as of November 30, 2017, are being duly executed and filed by Azza Diasti-Kennedy, director, to amend and restate the Corporation's original articles of incorporation which were filed on April 16, 1993, and amended on September 20, 2007. These Amended and Restated Articles of Incorporation were duly executed and are being filed pursuant to Section 607.1002 of the Florida Business Corporation Act as follows:

#### ARTICLE I Name
