## ARTICLES OF DISSOLUTION

Pursuant to section 607.1403, Florida Statutes, this Florida profit corporation submits the following articles of dissolution:

FIRST: The name of the corporation as currently filed with the Florida Department of State is Shorewood Financial, Inc. (the "Corporation") with its principal place of business located at 625 North Flagler Drive, Suite 600, West Palm Beach, Florida 33401
