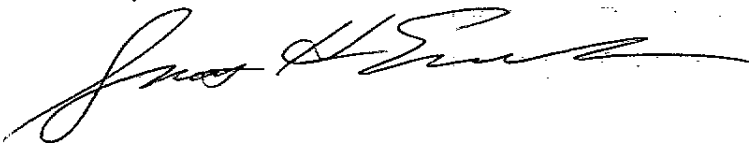

As from this moment forward I am no longer an employee of D.J. Gorman, Inc. as made reference to in the contract, Paragraph #14.

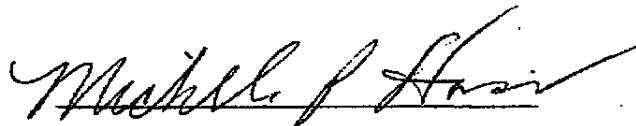
