To Whom it May Concern:

I would respectfully request that you accept this check for \$300.00 for filing fees for the year 1999 and the year 2000 with the following explanation.

In the fall of 1999 I received a notice from you the fee for 1999 was due and was in fact late. I called the Division of Corporations and explained that I had not received the original request for 1999. I was told to write a letter to that effect and to send \$150 and the late fee would be waved. On Oct. 15<sup>th</sup> I wrote a check for the amount stated (check number 2251). I heard nothing back and assumed it was in process. In December of 1999 I applied for my county occupational license and was told my corporation was dissolved.

I then called this division and was told that you never received the additional information you requested and therefore dissolved the corporation. I had been awaiting any communication since I sent my check. I would have promptly send any request back and I have nothing pending in this office.

It is very important to note that after three bank statements, this check has neither been cashed and neither has it been returned to me through the mail. It is most probably with you somewhere as is any information you might have requested after the check was sent. Since I have no check to show you I have enclosed a copy of my check register to show it was written.

Between managed care slashing reimbursements and the fact that I discovered in 1999 that my manager had been embezzling since 1996 ( she


