AMENDMENT TO THE ARTICLES OF INCORPORATION OF ONE WAY ELECTRIC, INC.

BEFORE ME, the undersigned authority, this day personally appeared Orestes Garcia and Orestes Torres who first by me being duly swom deposes and says;

That pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

First: Be it amended that Article V of the original Article of Incorporation has been changed to add Orestes Tomes as Vice-President, and Director of the company.
