Our family <u>Sigmund Echtler</u> (German with green card since 2004); <u>Sylvia Victoria Sargent-Echtler</u> (US citizen); the children Alexandra, Marcus and Bianca (US citizen), our companies <u>ESA Holding</u>, <u>Inc.</u> (P93000028524, FEI #65-0410031) and <u>ESA International Industries</u>, <u>Inc.</u> (P93000031067, FEI #65-0410030) are affected from international white collar crime and identity theft. Sigmund is President and Sylvia is Vice President.

Regarding identity theft we had in 2004 reported and undetected burglaries. Members of an international crime organization (America, Europe) stole our original identity certificates (parents, kids, and grand parents) and replaced them with altered and faked papers. It is a very huge and difficult document forgery / fraud and it seems that in 1994 (when we immigrate) starts a plan to rob at the end our full identity.

As we know today the crime organization organized for us total communication isolation and manipulated everything. We have problems with fraud regarding our computer net work, phones, fax, and an unbelievable mail fraud (incoming and outgoing mail). Because the mail fraud the crime organization has access to any important document like passports, driver license, green card, social security cards, insurance documents, titles, tax application, and all legal documents regarding our companies. We try anything and have no really chance to stop the mail fraud.

ESA Holding, Inc. is also mother of the Czech company ESA Interplan s.r.o. where the complete management is involved in the conspiracy to steal the ESA company group. Since we found out the hidden problems we lost any control of this company and our income. We expect that we are in Europe cheated with millions of Dollars because hidden turnover and wrong business information.

We believe that also our US companies are directly involved in the grand fraud with document forgery and conspiracy. Our share documents are stolen, articles of corporation and many other documents looks now faked, our complete bookkeeping looks altered. All this was just possible with surrounding conspiracy, big money and unbelievable influence.

When in 2004 all our business files were replaced than then we see that the ESA companies were founded in 1993. We remember that we found in 1994 and that papers in the past showed 1994. Also the corporation annual report and other business files what we have now in our house (after the burglary series) looks different in the content. This is not the same what we received yearly from Division of Corporation by mail and what we sent out with the mail including the check for the fee.

We realized from the internet, that the corporation annual reports in Tallahassee looks same like the replaced reports in our house which looks strange for us. We can her just describe a small part of the document forgery which we detect.

I will travel the next month to Tallahassee to look in person directly in the files of the authority to find answers about the fraud and proofs.
