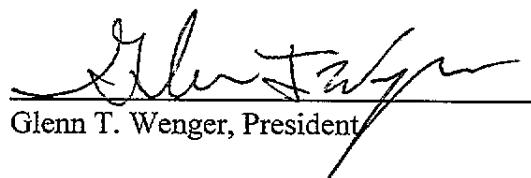

**THE UNDERSIGNED**, as President of **Equipment Parts of FL, Inc.**, a Florida corporation, Florida Document Number P93000031704 (the "Corporation"), in accordance with Section 607.1403, Florida Statutes, hereby adopts the following Articles of Dissolution for the Corporation:

1. **Name.** The name of the Corporation is Equipment Parts of FL, Inc.
2. **Date of Authorization.** Dissolution of the Corporation was authorized by written consent of the Corporation's shareholders on April 27, 1998.
3. **Statement Concerning Sufficiency of Vote.** The Dissolution of the Corporation was approved by the Corporation's Shareholders by their unanimous vote, which is a vote sufficient to approve the dissolution of the Corporation under the Corporation's Articles of Incorporation and Bylaws and under the laws of the State of Florida.
