Confirming your conversation yesterday afternoon with Eric in our office, we have not received a Corporation Annual Report Notice since 1995. When you checked your records, which reflected that the 1996 renewal Notice had been mailed to P.O. Box 4846, Winter Park, FL, it became clear why we had received no Notices. We have been at the above address in Sarasota since January 1, 1995. The Sarasota address is our only mailing address.

In view of the above and the fact that we have never had any reason or intention to cause LaserArt Corporation to be dissolved, we sincerely appreciate you re-instating LaserArt without the \$585 charge.
