

I have been incorporated in the State of Florida for the past eight years. During that time we have tried to comply with all filing requirements including the timely filingof the Florida Annual Report. Unfortunately, I did not receive the annual report notices from your office. When I went to apply for a new sales tax number I was told that the corporation had been involuntarily dissolved.

At this time we are respectfully requesting the abatement of the late filing fees for reinstatement, due to the company's history of prompt filings and the fact that we did not receive the renewal notices in the mail. It's possible that the mail was not delivered because a new mail carrier has taken over the route and the business address does not say Liberty Imports on the door.
