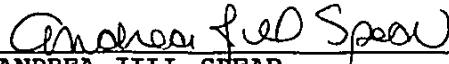

SECOND: The date of this amendment adoption shall be effective immediately.

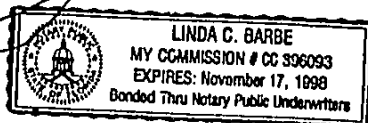
FOURTH: The amendment was adopted by the Board of Directors and Incorporator, and shareholder action was not required.
