ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
THE COMMUNICATIONS RESOURCE GROUP, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

First: The name of the corporation is The Communications Resource Group, Inc.

Second: The amendment to the Articles of Incorporation is as follows: The first sentence of ARTICLE I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE I.

The name of the corporation (hereinafter called the Corporation) is Team Connectivity, Inc."

Third: The foregoing amendment of the Articles of Incorporation was adopted as of the 17th day of November, 1999, by written consent of the Board of Directors and approved by written consent of the sole shareholder of the outstanding common stock of the Corporation as of the 17th day of November, 1999, and the number of votes cast for the amendment by the sole shareholder was sufficient for approval.
