ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, INTERNATIONAL FOAM SOLUTIONS, INC. (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation.
