Dear Ms. Smith:

We are in receipt of your August 29, 2006 letter concerning Sweet, Goss, Parker & Quinsey, P.A.'s (the "Corporation") corporate name change request. It is our understanding that the Florida Division of Corporations (the "Division") has initially denied the Corporation's name change request because the name designated by the Corporation in its name change request is unavailable. Specifically, the Corporation requested to change its name to "Goss, Parker & Quinsey, P.A." which is very similar to and allegedly not distinguishable from the name of an existing business entity registered with the Division. According to the information you provided with your August 29, 2006 letter, this business entity is "Goss, Parker, Quinsey, L.L.C."

In response to your letter, the Corporation's attorney, Michael R. Lowe, contacted you on September 21, 2006 to discuss this matter. During his discussion with you, Mr. Lowe explained that the three owners of Goss, Parker, Quinsey, L.L.C., namely the three (3) undersigned individuals, are also the three named owners in the Corporation. Thus, the names "Goss," "Parker" and "Quinsey" refer to the same individuals in both the Corporation and Goss, Parker, Quinsey, L.L.C. Based upon this fact, Mr. Lowe inquired as to whether the three (3) of us could waive the conflict caused by the similarities between the names "Goss, Parker & Quinsey, P.A." and "Goss, Parker, Quinsey, L.L.C." Mr. Lowe's understanding of your answer to this question is that such a waiver is possible, and that you and the Division need written confirmation from the three (3) of us

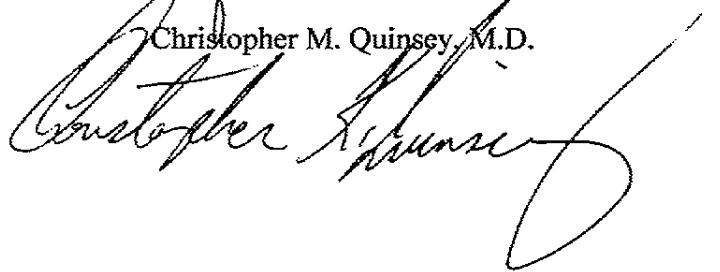

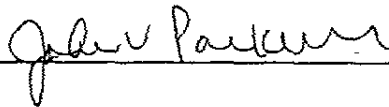
