**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
OSCAR J. FIGAROLA, M.D., P.A.**

Pursuant to Section 621 of the Florida Business Corporation Act, the Articles of Incorporation of **OSCAR J. FIGAROLA, M.D., P.A.**, a Florida professional corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is **OSCAR J. FIGAROLA, M.D., P.A.**

SECOND: The sole Shareholder and sole Director of the Corporation have consented to the conversion of the Corporation from a professional service corporation under Section 621 of the Florida Business Corporation Act to a profit corporation under Section 607 of the Florida Statutes, to be effective as of the date of filing of these Articles of Amendment.

THIRD: "Article I. Name" of the Articles of Incorporation is amended in its entirety to read as follows:

"ARTICLE I

NAMP: The name of the Corporation is **OSCAR J. FIGAROLA, M.D., INC.**"

FOURTH: The Corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

FIFTH: The foregoing amendment was adopted by written consent of the sole Shareholder on October 21, 2010, constituting a sufficient number of shareholder votes to approve the amendment.
