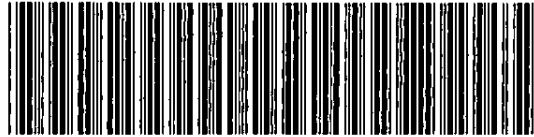

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
FLORIDA ACADEMY OF IMPAIRMENT RATINGS, INC.**

Pursuant to the provisions of Section 607.1001 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment, amending and restating in their entirety its Articles of Incorporation as follows:

1. The name of the corporation is FLORIDA ACADEMY OF IMPAIRMENT RATINGS, INC.

2. The following are the Amended and Restated Articles of Incorporation adopted by the Shareholders of the Corporation on February 5th, 2008, in the manner prescribed by the Florida General Corporation Act:

RESOLVED, that the Shareholders and Board of Directors of the Corporation have determined and adopted these Articles of Incorporation of FLORIDA ACADEMY OF IMPAIRMENT RATINGS, INC. as hereby Amended and Restated in their entirety as follows:

ARTICLE I - NAME

The name of this corporation is FLORIDA ACADEMY OF IMPAIRMENT RATINGS, INC. The principal address of said corporation is 118 SW Ft. King Street, Ocala, FL 34471.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

4.1 This corporation is authorized to issue 500 shares of \$1.00 par value common stock.

4.2 Stock Certificates. Certificates of stock shall be signed by the president or the vice president, joint with the secretary and the seal of the corporation shall be impressed thereon.

4.3 Shares Not in Classes. The shares of the corporation are not to be divided into classes.

ARTICLE VI - SUBSCRIBERS AND THE INITIAL BOARD OF DIRECTORS

6.1 The corporation shall have two (2) Directors. The number of Directors may be increased or decreased from time to time by the By-Laws, but shall never be less than one (1). The name(s) and address(es) of the Director(s) of this corporation are:

6.4 At a special meeting of shareholders called expressly for that purpose, directors may be removed in the manner provided by the By-Laws.

Any contract or other transaction between the corporation and one or more of its directors, shareholders or employees, in which they are interested, directly or indirectly, or between the corporation and any corporation or association of which one or more of its directors, shareholders, members, officers, or employees, have an interest, directly or indirectly shall be valid for all purposes, notwithstanding the presence and participation of such interested persons at the meeting of the board of the corporation that acts upon, or in reference to the contract or transaction; provided, the interested party does not vote or participate in the action; that the interested party discloses his interest before action is taken, and the contract or transaction is fair and reasonable as to the corporation at the time it is authorized by the board or its shareholders. This Section is intended to expand the ability of the corporation to conduct business with interested parties and shall not be construed

to invalidate any contract of other transaction that would otherwise be valid under the common and statutory law applicable to it.


ARTICLE VIII - INITIAL REGISTERED AGENT AND OFFICE

The corporation reserves the right to amend the articles in any manner now or hereafter permitted by the law, as provided by the By-Laws.

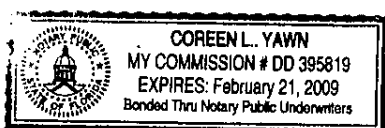


