- 1. That the name of the corporation is VINTAGE LAKE, INC.
- 2. The Articles of Incorporation of said corporation are hereby amended by deleting all words and figures contained in ARTICLE V CAPITAL STOCK and inserting the following in the place and stead thereof:

"ARTICLE V - CAPITAL STOCK
