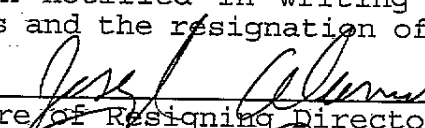

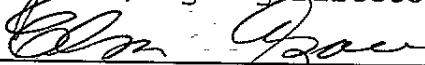

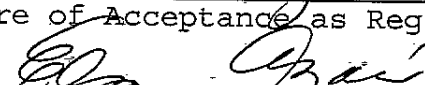

Signature of Resigning Director/Officer



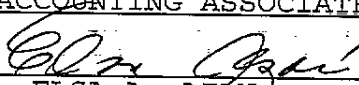
