I'm writing on behalf of our client, Suncoast Property Maintenance of Broward Inc. Our client recently learned that his corporation has been dissolved as of 9-21-01. In April of 2001 he filed his annual report with address changes before he relocated to Central Florida. He never recieved any notices or correspondence from your office, he assumed everything was fine. Mr. Willis first learned of his Corporation being dissolved in December 2001 when a problem arose from his insurance. He called your office immediately to see what he needed to do to update the Corporation. He was instructed to send a check in the amount of \$150.00 along with a letter, which he did right away. Again he didnt recieve any notices or correspondence from your office. I called the Division of Corporations on March 19, 2002 and was told that everything he sent in was returned to him.
