Subject: Uniform Report Late Fee

I am writing this letter in request that the late fee for filing the Uniform Business Report be abated. NGU Enterprises has been conducting business for several years now and to my recollection we have never failed in our submission of the Uniform Business Report (Annual Report). I made contact with a Division of Corporation employee via telephone conversation on July 20, 2000. This person advised me to submit this letter for consideration with an explanation of why we failed to comply with the submission deadline.

NGU receives mail at an address separate from where it conducts business. The original Uniform Business Report was mailed to this alternate address and, unlike the second notice, was not properly forwarded to NGU along with our other mail. I was not aware of this situation until receiving the second notice on the above date.

NGU Enterprises is not a large company and we operate on a small profit margin. NGU cannot afford this penalty at this time and is strongly requesting that you respectfully consider not penalizing NGU. I submit to you that NGU always operates within governmental guidelines and enjoys conducting business. However, if we are required to pay this penalty at this time, we will be forced to cease business operations.

NGU is also requesting with this Uniform Business Report that our mailing address be changed to match our principal place of business to alleviate this situation from possibly occurring in the future.
