

THE UNDERSIGNED, as President of **EVERYTHING BUT WATER TOO, INC.** a Florida corporation, Florida Document Number P93000043062 (the "Corporation"), in accordance with Section 607.1403, Florida Statutes, hereby adopts the following Articles of Dissolution for the Corporation:

1. Name. The name of the Corporation is Everything But Water Too, Inc.
2. Date of Authorization. Dissolution of the Corporation was authorized by written consent of the Corporation's shareholders on November 20, 1998.
3. Statement Concerning Sufficiency of Vote.
